Term

The successful applicant will be permitted to graze stock for a period of 3 years commencing 1 November 2024 and terminating 31 October 2027.

Rental

The amount payable by the successful applicant will be determined by Council and will be payable in advance and inclusive of GST.

NB: CPI increase will be applicable to the Licence amount for years 2 and 3

Application fee of \$270.00 applies if successful, as per Council's Fees and Charges 2024/2025.

Rates and Other Charges Payable

Council will remain responsible for any rates payable on the land. The successful applicant will be responsible for the payment of any water usage charges, as determined by Council.

Fencing

Applicants should submit their expression of interest on the basis of the property in its present state. The successful applicant will be responsible for ensuring that the fencing is maintained and kept in a stock-proof condition.

Public Liability Insurance

The successful applicant will be required to effect Public Liability Insurance for an amount not less than Twenty Million Dollars (\$20,000,000.00) in the joint names of the parties and provide Council with a copy of their Certificate of Currency.

Mandatory - Bushfire Prevention Plan

Applicants will be required to outline steps to be undertaken to minimize the danger of bushfires starting and spreading from the land as required under Rural Fires Act 1997, and should be submitted as an addition to the expression of interest form.

Expressions of Interest

Expressions of interest should be submitted on the attached form and forwarded to reach Council by 10.00am on Monday 21 October 2024 by email or in a sealed envelope marked "Expressions Of Interest – Grazing Licence – 29 Nioka Road Jindera"

Expressions of interest should be based on the annual rent to be offered for the right to graze stock.
